## TUITION SCHEDULE and FEES 2019-2020

In order to assist the parents and students understand the costs and fees required at NMCA and to facilitate the payment of these costs, the following set of procedures and definitions have been established:

- **Registration fees** are required for each student enrolled at the time the application is made.
- **Registration fees** are non-refundable and non transferable unless the student is refused admission. **The early registration is \$60 if paid on or before June 30<sup>th</sup>.** After that date, the fee is \$100.
- **Book fees** are to be paid prior to the first day of school each year. Student textbooks that are consumable are to be purchased by the parent or legal guardian; non-consumable textbooks will be rented. The book fees are due by the first day of school and are as follows: Kindergarten - \$100; 1<sup>st</sup> through 6<sup>th</sup> Grades - \$130; 7<sup>th</sup> through 12<sup>th</sup> Grades - \$160.
- **Tuition payments** may be lump sum or paid according to the schedule below. Monthly tuition payment is due by the 10<sup>th</sup> of each month. First tuition payment for the coming school year is due by August 10<sup>th</sup>.
- **A graduation fee** of \$65 is paid by each enrolling senior to cover the cost of cap, gown, and diploma.
- **Special fees** may be assessed to cover costs of trips, special materials, etc.

- **Financial Assistance:** It is our firm belief that all children should be given a Christ-centered education, but we recognize that the cost of tuition may be beyond some parents' ability. It is therefore our policy that **no child shall be denied enrollment based solely on financial hardship.** If you cannot meet the required tuition amount, please make an appointment to speak with Jon Thompson or Pastor Rusty Chatfield. Any parent who cannot meet their financial responsibility must submit to financial counseling, be willing to make reasonable changes in their budget to pay any partial tuition, and be available to do designated work assignments for NMCA.
- **Pastors and Missionaries** will be offered a 50% reduction in tuition fees.
